





#### **VAT**

Each Academy must consider whether or not they are required to register for VAT and if it is not required, whether or not it will still be beneficial to do so. Academies are also able to reclaim their input VAT via the VAT 126 form. The best course of action depends on the Academy's individual circumstances.

## Independent checking of financial controls

As laid down in the handbook, each Academy Trust must have in place a process for independent checking of financial controls, systems, transactions and risks. There are a number of options that are available to Academies to conduct this work, however, it is often preferred that a supplementary program of work is carried out by the external auditor.

## **Land & buildings**

One of the key areas to consider on conversion is the value of the assets and liabilities that will be transferred from the Local Authority. The value of the land and buildings and consideration for the period in which to depreciate these assets has a significant impact on the accounts.

#### LGPS pension liability

On conversion to an Academy, the trust will inherit the deficit (or surplus) on the Local Government Pension Scheme (LGPS). Consideration must be given to the value inherited and then a valuation must be obtained for the year end position from the Actuary involved in administering the scheme. There are complex accounting and disclosures required regarding pensions.

## **Related party transactions**

With public bodies under ever increasing scrutiny, related party transactions have become a key topic for Academies. There must be total transparency with regards to related party transactions, with new rules in place to ensure transactions are 'At Cost'. This area requires careful consideration.

#### **Bank accounts**

On conversion the Academy will need to open a new bank account. It is important to ensure that proper authorisation processes are in place to meet the requirements of the Academies Financial Handbook.

## **Accounting systems**

For many the change to Academy status brings enough challenges in itself without adding a change of software in the mix. However, many may see this as an opportunity to change to an alternative supplier. Even if you maintain your current software there will be a change to a new chart of accounts to reflect the new reporting requirements.

#### **Trustees responsibilities**

A Governor of an Academy is also a Trustee of a charity and a Director under Company Law. This brings extra legal responsibility that everyone must be made fully aware of.

# **Reporting requirements**

With Academy status comes a new reporting regime. Instead of reporting to the Local Authority, Academies will report direct to the ESFA. Academies must ensure they comply with the Funding Agreement with the ESFA, The Academies Financial Handbook and The Annual Accounts Direction. The key reporting documents include:

- Budget Return
- Academies Accounts Return
- Financial Management and Governance Self Assessment
- · Land and Buildings Return

- Value for Money Statement
- Regularity Reporting
- Annual Statutory Accounts
- Teachers Pensions EOYC
